THE @RATING CREDIT OPINION

An @rating symbol is shown against a company where we rate it up to a defined amount. The seven @rating Credit Opinion levels are as indicated. Our credit insurance clients can trade up to these levels and be covered.

Letters are used to denote lower amounts, for example 'R' or, in the case of a zero credit rating, an 'X'. If a company is not yet rated this is indicated by 'NR' – Not Rated. In such cases, we would investigate the entity for you.
